CAN A BIRD HAVE TOO MUCH CALCIUM?

The simple answer is yes but the more accurate answer is of course much more complicated and is dependent on factors such as where the bird originated from e.g a country like the Australian environment or a more tropical environment such as those found in Asia and South America. These will determine the actual balance of elements such as Phosphorus and Vitamin D3 necessary to process Calcium in a healthy diet.

As an example Cockatiels, budgerigars, some grass parakeets and finches live in arid climates and eat mainly lower nutrient, seed diets. They have evolved to conserve nutrients and water and thus they may be more sensitive to high levels of calcium and D3 in their diets. Birds of the neotropics, with access to abundant, varied foods, have not needed to conserve nutrients in their body and may have higher daily dietary needs.



Excess calcium from supplements, fortified foods and high-calcium diets, can cause the "milk alkali syndrome," which has serious toxicity and can be fatal. Excessive calcium intake can lead to hypercalcaemia (an elevated calcium level in the blood), complications of which include vomiting, abdominal pain and altered mental status. High calcium intakes can also lead to constipation, an increased chance for developing calcium kidney stones, and may inhibit the absorption of iron and zinc from food. Too much calcium can also cause the shell glands in the uterus to over-produce calcium, sometimes making the shells to adhere to the uterus, making it difficult (if not impossible) for the hen to lay the egg.

A particular example was highlighted in a study of the Dietary Requirements and Toxic Levels of Calcium and Vitamin D3 in Budgerigars (see www.bestofbreeds.net/wbo/article7.htm). According to the study a moderately common problem seen in budgerigars and some other species of birds is calcium deposition in the kidney resulting in kidney failure. The cause of this disease has been hypothesized to be either excess calcium or vitamin D3 in the diet. To determine the cause of this disease, groups of budgerigars were fed diets containing various concentrations of calcium and vitamin D3 and allowed to breed. Results of this study showed that budgerigars need less dietary calcium (0.3%) than most other species for growth and egg laying.

When dietary calcium concentrations reached 0.7%, mild calcium deposition occurred in nestlings and adults. When calcium concentrations reached 1.5%, death occurred in chicks and adult birds. All seed diets containing less than 0.3% calcium resulted in weak bones in laying hens and their eggs did not hatch. Vitamin D3 concentrations ranging from 500 to 3,300 International Units of Vitamin D3 per kilogram of diet did not cause calcium deposition in the kidney as long as diet did not contain more than 0.3% calcium.

This research suggests that budgerigars can only tolerate a narrow range of calcium in their diet. Calcium concentrations in seeds are insufficient, but calcium concentrations found in most pelleted diets will be too high and could be toxic. Therefore, it is necessary to supplement seed diets with some form of calcium, e.g., cuttlebone and if you are going to feed pellets, they should be no more than 25% of what a budgerigar eats. This research also shows however that budgerigars can tolerate a wide range of vitamin D3 concentrations in the diet without problems.

According to Ron Hines DVM PhD in an article at The Avian Web site adding Vitamin D to commercial diets is always risky when those same diets already contain correct amounts of Vitamin D. This is because too much Vitamin D is as bad or worse than not enough. The problem with Vitamin D is that in high doses it can be very toxic. It can cause hypercalcemia (too much calcium in the blood) which affects the heart, other organs and will cause liver toxicosis. At 3-5 times the required amount, Vitamin D3 can cause calcification of the kidneys and stomach (proventriculus) of birds and gout in mature birds – probably due to kidney damage. You can get that high if you feed your birds a lot of egg yolk, or certain fish oil supplements in addition to their regular diet.

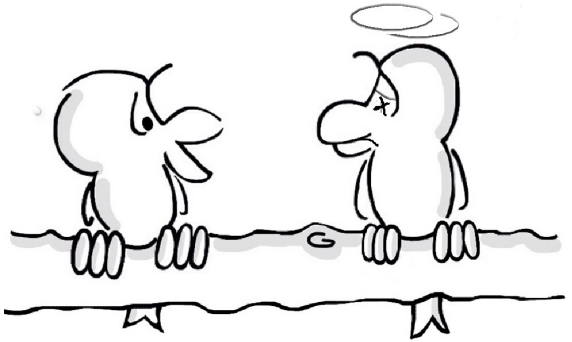


PARROTS GET DRUNK AFTER EATING FALLEN, FERMENTING MANGOES IN THE KIMBERLEY

It is the end of the mango season and the fallen fruit is fermenting in the Kimberley sun, resulting in a boozy treat for the local wildlife.

Paul Murphy, said several lucky birds had been brought into the clinic.

“So far, we've seen about half a dozen in total, but there are a lot of them, unfortunately, that don't make it to the clinic because they pass away before people find them,” he said. “Usually, they've been suffering for a couple of days. That's generally when people are able to pick them up and catch them. They're quite lethargic and at various stages of malnutrition.”

The local veterinarian said it was not just alcohol that was killing the parrots, but their "drunken behaviour"

"We're hearing a few reports of flying into windows and sitting on the floor, not being able to fly and being vulnerable to cats and other predators," he said.

It is unclear why red-winged parrots seem to be the only birds heavily affected by fermenting mangoes.

Some scholars suggest it could be because mangoes are the only wildly available fruit throughout the Kimberley that ferment potently.

Doctor Michael Considine, an Associate Professor in Plant Molecular Biology at the University of Western Australia, says it is all part of the ecological system.

“Once the fruit are ripe, the next phase will be fermentation where the sugars will take the pathway to become alcohol and that process makes the aroma compounds volatile which attract the birds and other animals,” he said. "The ethanol is clearly serving some sort of ecological value for the tree.”

But not all tropical fruits can be as alcoholic as the humble orange fruit.

"Mangoes are particularly unique because they're so sugar rich and that can produce high levels of alcohol. Whereas a number of the other tropical fruits are not quite so dense and more watery."

Mr Murphy warns the public not to assume a red-winged parrot is tame.

"Even if they let the person pick them up, generally it's because they very unwell," he said. "Rather than taking it home and putting it in a cage, bring them to the vet so we can assess and see what it needs."

Is it the alcohol or is it illness?

In 2010, the ABC documented the same intoxication habits in lorikeets in Darwin.

But in 2016, Darwin-based vets found their lorikeets were dying due to illness, referred to as Drop Lorri Syndrome, rather than intoxication.

The Broome Veterinary Clinic is looking at whether or not ethanol poisoning, or something more sinister, is to blame for the birds' deaths.

Mangoes fall to the ground and ferment quickly in the Kimberley heat. (*ABC Kimberley: Hinako Shiraishi*)

In the meantime, Professor Considine confirmed fermented mango is not harmful to humans because we are unlikely to eat a mango that has reached that point.

"It's a unique smell," he said. "People would know if they were eating a mango that had gone so far as to have appreciable levels of alcohol.

DID YOU KNOW.....

'TERRITORIAL' RAVENS DISRUPT SURGE IN CANBERRA'S DRONE DELIVERIES UNDER LOCKDOWN

Is it a bird? Is it a plane? It's a raven swooping on a drone attempting to make a delivery to a Canberran craving caffeine.

A battle for aerial dominance is emerging as nesting season coincides with a surge in demand for drone deliveries during Canberra's lockdown.

Drone delivery service operator Wing has paused flights in the northern suburb of Harrison while bird experts assess the behaviour of local ravens to ensure their welfare is safeguarded.

In written feedback provided to a customer, Wing advised: "We've identified some birds in the area demonstrating territorial behaviour and swooping moving objects.



"While this is common during nesting season, we are committed to being strong stewards of the environment, and would like to have ornithological experts investigate this further to ensure we continue to have minimal impact on birdlife in our service locations. It would be like a flying saucer landing in our front yard'

Harrison resident Ben Roberts, who has been taking advantage of Wing deliveries during the lockdown, managed to capture the video of the raven swooping on his coffee order.

"It's just good to be able to grab a quick brew without having to get in the car, drive to a cafe, mask up, interact with other people and unnecessarily expose yourself to Delta when I can just order it to my front yard," Mr Roberts said.

He was not aware of any birds being injured but he supported deliveries being halted while investigations are carried out.

"We don't want them getting injured, they're an important part of our environment here," he said. "I think I saw them swooping a garbage truck the other day ... although I haven't seen them attack any people which is good. But they are certainly very territorial at the moment. From their point of view, they're very intelligent birds, what must a drone look like to them? It would be like a flying saucer landing in our front yard to us."

Ornithologist Neil Hermes said ravens were known to attack anything coming near their nests, especially wedge-tailed eagles.

"They will swoop dogs and activity around their nets, but attacking drones is new," he said. "The bird appears to be perfectly unharmed by the fact it's attacked this drone, and given that Wing are not currently flying in the area, the bird probably feels it has been successful in driving it away. If you were to interview the birds today, I think you would find they felt that they'd won. [The raven] has won, at least in the fact deliveries are not occurring in the next little while and it's demonstrated its mastery of the space."

Mr Hermes had advised Wing to pause deliveries if they were disrupting nesting in certain areas and said it was "a good result" that they had done this.

"That's what Canberrans want in the suburbs – is to have the wildlife get on with its business around us," he said. "And when we have any activity that disturbs the wildlife, we like to see practices put in place where we can reduce that and eliminate it if we can and I think that's what happened in this case."

THE TRAGEDY OF THE PARADISE PARROT

Exactly 100 years ago tomorrow, a bird that had been relegated to extinction made a comeback. The exquisitely beautiful paradise parrot was re-discovered by Cyril Jerrard, a grazier from Gayndah in Queensland's Burnett district, on December 11 1921.

But its return was fleeting. Scattered pairs were seen around Gayndah until 1929. Some were seen around nearby Gin Gin in the 1930s. After that came only rumour and hope. Today, the paradise parrot has the tragic status of extinct. It's the only mainland Australian bird species known to have suffered that fate since colonisation.

On the 100th anniversary of the parrot's rediscovery, we might revisit the event and consider why the bird's resurrection was so brief. From that, we may gain insights into how to help the many species threatened with extinction today.

Our 'avarice and thoughtlessness'

In 1924, a few years after rediscovering the paradise parrot, Jerrard identified the reasons for its decline. "Directly by our avarice and thoughtlessness," he wrote, "and indirectly by our disturbance of the balance so nicely preserved by nature, we are undoubtedly accountable for the tragedy of this bird."

Although a grazier, he acknowledged "the most fatal change of all" was wrought by the pastoral industry.

Jerrard's collaborator in trying to save the bird, the journalist and bird-er Alec Chisholm, also nominated pastoralism – especially the burning of grasslands – as a main factor in the decline, along with trapping for the aviary trade and feral cats.

But while Jerrard and Chisholm could point out why the paradise parrot was sliding towards extinction, they were unable to do much about it. In books, newspapers and magazines, Chisholm publicised the parrot's plight and pleaded for its preservation. His pleas didn't exactly fall on deaf ears, but they were inadequate to counter a social ethos that privileged economic gain over avian loss.

Besides, ornithologists in the 1920s and 1930s had a lamentably limited repertoire of strategies to save endangered species.

On the latter issue, things have changed dramatically. We now have comprehensive scientific studies of the risks facing endangered species, and a vast array of remedial measures.

There are gaps in the science and imperfections in the conservation strategies, but there is a potential to rescue endangered species today that was lacking when the paradise parrot was rediscovered.

Lessons for the golden-shouldered parrot

Take, for example, the paradise parrot's close relative, the golden-shouldered parrot of Cape York Peninsula. Currently listed by the International Union for the Conservation of Nature as endangered, it faces threats similar to those that annihilated its southern cousin last century.

In the heartland of golden-shouldered parrot territory, pastoralists Sue and Tom Shephard are devoted to preserving the parrots on their station, as was Jerrard 100 years ago. But unlike the Gayndah grazier, the Shephards have scientific backup.

From the pioneering studies of environmental scientists in the 1990s to more recent investigations, scientists working on Cape York Peninsula have scrutinised the species' needs and advised on how to safeguard them. They place particular stress on fire management.

The birds eat seeds from several preferred grasses, which require specific fire regimes to thrive. The availability of seed affects the parrot's breeding success. Fire also helps maintain the birds' grassy woodland habitat and leaves fewer places for predators to hide.

But since European colonisation, fire regimes in Australia have changed dramatically across northern Australia. It has meant the golden-shouldered parrot has less food and is more vulnerable to Chisholm in the 1920s knew fire had something to do with the paradise parrot's demise, but his writings on the topic were sketchy and vague. There was then no clear understanding of the fire ecology of this land, still less of the role of Indigenous fire regimes or willingness to learn from them.

Now, we have detailed calibrations of the type and intensity of fires needed to ensure breeding success for the golden-shouldered parrot and to minimise its loss to predators. Traditional owners of its territory, the Thaypan and Olkola peoples, collaborate with pastoralists and ecologists, linking traditional knowledge with Western science to reestablish fire regimes beneficial to the parrot.

While we're better equipped today to rescue endangered species than was the case for the paradise parrot last century, that's no cause for complacency.

Despite the superior conservation strategies and technologies now available, the drivers of extinction identified by Cyril Jerrard in the 1920s – our “avarice and thoughtlessness” – remain stubbornly persistent.

Prioritising bird welfare

If we're to ensure the golden-shouldered parrot and other endangered species do not go the way of the paradise parrot, we need scientific strategies and technologies.

But we need more than those. Sometimes, at least, we need to subordinate avarice to avian welfare.

For that, we need to connect, emotionally and ethically, with the birds around us. Birds must matter to us – not merely in an abstract or objectified fashion but as beings of intrinsic worth.

That's what Chisholm was getting at in his 1922 book, *Mateship with Birds*, the concluding chapter of which was titled “The Paradise Parrot Tragedy”. In the lavish language then fashionable among nature writers, he urged readers to:

“dispute the dangerous idea that a thing of beauty is a joy for ever in a cage or cabinet; and disdain, too, the lopsided belief that the moving finger of Civilisation must move on over the bodies of ‘the loveliest and the best’ of Nature’s children”.

He and Jerrard lacked the tools and technologies to avert the paradise parrot's tragedy, but not an appreciation of our moral responsibility to try to do so. We now have the tools and technologies, but our moral compass seems as fickle as ever

CALL FOR FARMERS TO HELP SAVE RED-TAILED BLACK COCKATOOS

The South Eastern Red-Tailed Black Cockatoo is an endangered species, with only 1500 left in the wild and Trees For Life is hoping to turn this number around, with their Communities helping Cockies project. At the same time they are calling on property owners across the South East to help in their efforts.

Buloke is one of three native tree species that the cockies will feed on, and it is the rarest, with less than three per cent of original buloke trees still standing in the South East.

Landowners near Mundulla, Wolseley, Frances, Kybylote, and Hynam are being asked to plant buloke trees (*Allocasuarina luehmannii*) if they have suitable land. The planting of these trees will provide both food and habitat and it is hoped that by increasing their number the local population of Red-Tailed Black Cockatoos will increase.



Trees For Life Habitat Officer, Cassie Hlava explained this is a crucial project.

"The Communities helping Cockies project is providing funding to cover the cost of plantings but we really need help to find more suitable sites," she said.

The project is supported by the Limestone Coast Landscape Board, through funding from the Australian Government's National Landcare Program and is delivered in partnership with Birdlife Australia, Zoos SA and Trees For Life.

To become involved in the project farmers should contact Trees For Life, who will help every step of the way, and provide everything necessary to complete the work. A team member will come out to the property to work out a plan with the farmer and from there, contractors will be sent out to plant buloke seedlings. Participating landholder, Jess Livingston was able to have 200 buloke trees planted onto her property.

"Participating in the project was great," she said. "We were involved in the planting and fencing aspects and the team who completed the work were all very lovely. They involved our children in the aspects that they could help with, so that made it a really enjoyable process."

"For us it is a nice continuation of the work that has already been done here by previous owners and custodians of the land that we hope to continue on with."

Trees For Life Revegetation Services Manager, Vick-Jo Russell is excited to get the project going.

"Don't put it off," she said. "We'd love to get it started."

The Communities for Cockies project will run until June 2023.

President Sam Davis presented reported on:

Proposed National Registration Scheme for Native and Exotic Live Birds.

The latest update from Canberra this week indicates the report is currently being finalised in Canberra and next steps will be advised in the next few weeks.

I have asked that a representative from the Wildlife Trade Office in Canberra and/or from the consultants Thinkplace address our March CCBFA meeting. This may be premature so will more likely occur at our May CCBFA meeting.

I continue to remain in regular contact with the Wildlife Trade Office.

Victorian native licensing review.

I'm advised this week that the Panel report containing recommendations for the Wildlife Act Review (including into native bird licensing) will be made publicly available when it is released with the Victorian Government's Draft Directions Paper. The Draft Directions Paper will include a response to the Panel's recommendations. This will take place in approximately April of this year.

I was made aware via Mark Godwill (VAC) – thanks Mark - that an individual aviculturist was successful after many year in having Noisy Pitta added to Schedule 3 Part B of the Wildlife Regulations 2013. This allows Noisy Pittas to be kept by "Wildlife Advanced Licence" holders under Reg 8.

I have made initial contact with the individual aviculturist as the legal reasoning used may prove invaluable for negotiations in Victoria and other states. I understand it relied at least in part on sections of the Australian Constitution and reciprocal arrangements between the states – but to be confirmed.

I have invited a representative from DELWP in Victoria to address a CCBFA meeting soon after the release of the Panel's recommendations. Possibly at our May meeting.

Victorian animal welfare act review

You may recall the long drawn-out process for creating a new Animal Welfare Act in Victoria. Our most recent submission to this process was back in December 2020.

Current advice indicates a draft of the proposed Animal Welfare Act will be released sometime in 2022.

There are a range of issues influenced by extreme animal rights ideologies in play in Victoria that ACA is dealing with currently. Most do not directly affect birds, however it is clear from the meetings I have attended and the reports .

back to ACA from ACA Dog and other representatives that animal rights extreme views are chipping away at the ability to keep pets in Victoria. Vigilance is required.

NSW native licensing

You will be pleased to know that we have progress at long last!

The Acting Executive Director, Conservation, at NPWS rang last week to apologise for the delay and explain how the matter will progress. The current timeline is to have a draft Code of Practice out for public exhibition in the first half of the year, with the matter finalised by October 2022. She subsequently emailed to confirm as much.

Note that this NPWS Code of Practice includes animal welfare and will also list species of birds which will be on and off licence.

I have since spoken to Peter Stathis of NPWS who is tasked with employing a leader and other staff for this process. I know Peter well and we will be in regular contact over coming weeks to refine the process going forward.

There are contentious issues and others where we agree. Peter claims the risk assessment for the 32 species that were agreed to go off licence were never completed. This conflicts with advice from others including our CCBFA appointed member of the previous expert panel and the results of the 2 GIPA requests lodged on our behalf by ACA.

Nevertheless, this is progress after so many meetings with Ministers, MPs including questions to a parliamentary inquiry over the last 2 years since the reforms team was let go. Note that the first meeting about this matter was back in 2015.

NSW animal welfare legislation review, including parliamentary inquiries where ACA/CCBFA will appear.

A draft of the new NSW Animal Welfare Act (The Draft Animal Welfare Bill 2022 – The Bill) is out for consultation now. The Bill is proposed to replace all current animal welfare legislation in NSW; namely the Prevention of Cruelty to Animals Act 1979, the Animal Research Act 1985 and the Exhibited Animals Protection Act 1986. CCBFA will write a submission and your comments are welcomed.

There are a range of issues and political posturing going on currently that would require all night to recount, so I will briefly outline a few steps where both CCBFA and Animal Care Australia (ACA) are involved.

There are two relevant NSW Parliamentary Inquiries of relevance – one is specific to The Bill and the second is with regard to the RSPCA NSW. I will be presenting at both these Parliamentary Inquiries in my role as ACA Vice President.

The area where CCBFA will be most heavily involved will be the negotiations surrounding codes of practice aka standards and guidelines for birds. I regularly speak with NSW DPI, in particular the Chief Animal Welfare Officer, Kim Filmer, with whom I have the utmost respect. I spoke with Kim regarding this matter as recently as yesterday. As I have tried to make clear numerous times, we are better to ensure we are self-regulating effectively, transparently and united such that government will see no reason to enforce draconian regulation upon us. Our recently approved, professionally presented Bird Sale CoP is an example of how we can show government we are self-regulating. The Bill includes a “Minimum Care Requirement” for all animals (water, feed, shelter, exercise) which will apply if the Bill is passed – it is my view that this is sufficient in our circumstance in terms of legal requirements. Our CCBFA ratified codes, such as the bird sale code, would be ratified as policy by NSW DPI but will not be law. That is, RSPCA inspectors will enforce the “Minimum Care Requirement” but will have no role in enforcing our codes.

I cannot stress heavily enough the need for clubs to be united whilst this process and negotiations are finalised during 2022 and 2023.

ACT native (and exotic) bird regulation.

Bruce Goleby reported that the ACT government officer within the Office of the Conservator has confirmed changes will be made to remove the common aviary species from licence. The holdup is due to a lack of staff and resources rather than any opposition to the changes.

The changes in broad terms reflect the CCBFA submission to the Conservator of Flora and Fauna back in September 2019.

Bird sales and auctions code of practice – some issue over wire cages in NSW.

It appears the details and rationale behind our revised NSW bird sale code has not reached or been satisfactorily understood and relayed to some clubs, which is of concern. Many thanks to Bruce Goleby who has agreed and is in the process of contacting clubs who have expressed concerns.

The concerns, as I understand, are to date totally with regard to the use of wire cages for birds smaller than Rainbow Lorikeets. Some clubs, including some who's delegates voted in favour are now opposing this part of the code and wish to permit wire cages for all birds. Two clubs have decided to leave CCBFA as a consequence.

Can I make it 100% clear - our CCBFA code is not mandatory, CCBFA has no right to enforce the code on any clubs, we do not claim and have never claimed to have that right. Persons saying otherwise are simply incorrect. The aim is to have a united code that, as noted above, can be presented to government to prevent government forcing regulation including RSPCA inspectorate enforcement on us.

The bird sale code is quite a separate issue to our public liability insurance. Adherence with the code for bird sales is not linked to the insurance at all. Again, people claiming otherwise are simply wrong.

On the issue of wire cages or any other CCBFA matter – the decision on such things is the decision of the affiliate clubs who form the membership of CCBFA. If clubs feel strongly about an issue then they must ensure their delegate attends meetings and that their delegate speaks and/or votes in accordance with the wishes of the club they represent.

The bird sale code was passed unanimously in its current form. If clubs wish to have it edited, such as making standard S4.8 regarding wire cages a guideline for example, then bring that to the meeting, present your argument and it will be reconsidered.

Would anyone like to do that now?

Craig Jeffrey responded on behalf of the Shoalhaven Avicultural Society (not in his role as President of the Associated Birdkeepers of Australia (ABA)) that they had issues with the restrictions on all wire cages.

The matter will be reconsidered at the March 2022 general meeting with clubs informed prior.

Insurance

Craig Jeffrey also commented that a number of clubs were not happy with CCBFA insurance. (without substantiation) Craig claimed the CCBFA insurance was restrictive as the insurance did not cover everyone such as guests.

I (Sam Davis) explained to the meeting that all insurance policies only covered the insured parties. No insurance policy insures everyone without restriction.

In the case of CCBFA's public liability insurance, it is our affiliated clubs and their members whilst participating in club events that are insured. Anyone who is a paid member of any CCBFA insured club is insured at all CCBFA club events.

If someone who is not insured, that is, a member of the public (who may be a guest) is injured at a club event and a CCBFA club or member is at fault then as the club is insured they can claim under the CCBFA public liability policy.

If a person is selling, exhibiting or part of the event itself then they are deemed to be a participant. If that person causes injury or property damage to someone at the event then the club is likely to be found to be at fault. If the person is a member of a CCBFA club then they are insured and hence a claim on the CCBFA policy can be made. If the person is a non-member participant, then they are not insured and hence the club may be exposed and liable for the injury or property damage.

This is how all public liability policies operate – only the insured can make claims on the policy. An important extra coverage with CCBFA's public liability policy is the participant to participant coverage which is not a standard part of most public liability policies. This extra coverage means that if an insured participant injures or causes damage to another insured participant then a claim can be made.

This participant to participant cover (aka member to member cover) is not the case for most public liability policies. For example, if organisation ABC Inc. does not include this coverage, then at an ABC Inc. insured event, if an insured participant is found liable for injury or damage to another insured participant then no insurance claim can be made, and the club will likely be liable for the injury or damage costs.

CCBFA has made inquiries regarding statements made to us claiming the ABA policy covers everyone at ABA insured club events regardless of whether they are a member of an ABA insured club or not. The advice is clear – like all insurance policies, only insured parties are covered.

A policy to insure everyone would not be approved by any insurance company as the risk is enormous and unquantifiable, and even if such a policy was possible the premium would be equally enormous so not affordable.

ABA claimed national bird sale code of practice

It was recently brought to my attention that the Associated Birdkeepers of Australia (ABA) have released a document titled “ENDORSED NATIONAL CODE OF PRACTICE FOR THE CONDUCT OF BIRD SALES AND AUCTIONS”. This document claims to cover all bird sales and auctions nationally, including poultry and pigeon events.

I have contacted a range of representative bodies and clubs nationally - in WA, SA, Vic, Qld and ACT and so far, nobody, no club and no representative body has seen this code, consulted on this code or agreed to this code. Indeed, most have been shocked and appalled and others have stated the ABA is irrelevant and should be ignored.

CCBFA continues to share all communication with the ABA – they do not reciprocate. CCBFA some years ago attempted to meet to resolve matters with the ABA. I attended an ABA meeting and they agreed to meet, Ron booked a venue and then, as has been all too regular an occurrence, the ABA President Craig Jeffrey simply ceased to respond to emails.

The ABA code includes cage sizes as an Appendix lifted from the Victorian code. No NSW club I have conducted has been consulted about these cage sizes. You may recall our CCBFA discussions some time ago regarding mandating specific cage sizes was set aside due to difficulties measuring cages as sellers arrive.

The current ABA President Craig Jeffrey and ABA Vice President, Joe Habib are delegates to CCBFA (for the Shoalhaven Avicultural Society and the Avicultural Society of NSW respectively). I ask that these delegates explain themselves to the assembly.

Craig Jeffrey stated he was representing the Shoalhaven club not the ABA and hence said "No comment". Note that Joe Habib was an apology to this meeting.

The Secretary reported that as at the 2nd February, payments for six clubs were in progress three clubs did not require the insurance two had folded. The secretary to allow outstanding clubs to pay by 28th February before advising the insurance company of cancellations.

Moved C. Jeffrey and seconded by J. Tadjell that the Reports be accepted, and Reporters thanked – Carried

- **Show and Sale dates for 2022** – Clubs are requested to email the Secretary the dates for their 2022 shows, sales and auctions, including phone number of the contact person and venue details. It is understood that confirmation of the venue may be in abeyance / pending, however we request the tentative / projected dates be advised. Email ccbfa@aapt.net.au
- **RAS** has confirmed the show dates for the Aviary Bird show at the 2022 Royal Easter Show, entries close 16th February and the two day show days will be Tuesday 12th and Wednesday 13th April 2022. The President thanked the delegates for attending, as there was no further business the meeting closed at 9:24 p.m.
